#### **BHIPP Services**

BHIPP provides support to pediatric primary care providers in addressing the behavioral and developmental needs of their patients.

#### Services include:

- Telephone consultations provided by our team of experienced child psychiatrists and behavioral health professionals.
- Telemental health services.
- Training opportunities covering behavioral and developmental topics.
- Referral and resource networking to help identify local resources tailored to the patient.
- Care coordination for the patient and family.

#### **Telemental Health Services**

When indicated, referrals to telemental health services are available free of charge and regardless of your patient's insurance status.

- Telepsychiatry (e.g., consultation, evaluation, medication prescribing)
- Telecounseling (e.g., cognitive behavioral therapy, motivational interviewing, etc.)

All telemental health services take place through a HIPAA-compliant encrypted video call at the PCP's office.

In all cases of direct patient care, BHIPP's Care Coordinator will work with the PCP and family.





## **BHIPP TeleECHO™ Clinic**

Project ECHO<sup>™</sup> (Extension for Community Healthcare Outcomes) is a collaborative model of medical education that improves access to specialty care by linking expert specialist teams with primary care providers through real-time, online learning sessions called teleECHO clinics.

- ✓ TeleECHO clinics connect BHIPP consultants with PCPs in their local communities to provide didactic presentations and case-based learning.
- ✓ Participants join teleECHO clinics from their own desktop or mobile devices using free videoconferencing software.
- ✓ TeleECHO clinics will improve providers' knowledge of mental health screening and evaluation, and in-office interventions, with an emphasis on behavioral and pharmacological interventions.
- ✓ Free CME and CEU credits.

## Who can participate?

✓ All levels of providers throughout Maryland are welcome and highly encouraged to participate, including: physicians, physician assistants, nurse practitioners, registered nurses, mental health practitioners, social workers and other related staff in pediatric primary care offices.
